



EXECUTIVE ORDER NO. 33 Series of 2022

AN ORDER ORGANIZING THE LOCAL SCHOOL BOARD OF THE MUNICIPALITY OF CAMALANIUGAN

WHEREAS, Article 184 of the Implementing Rules and Regulations of Republic Act 7160 mandates the creation of the Local School Board (LSB);

WHEREAS, education stands as one of the core priorities of the Municipal Government of Camalaniugan recognizing its importance as a great equalizer towards a better quality of life and as a building block of developing a culture of excellence;

WHEREAS, the recently concluded National and Local Elections has brought about changes in the mandatory composition of the board;

NOW THEREFORE,

I, **ISIDRO T. CABADDU**, **Municipal Mayor** of the Municipality of Camalaniugan, by virtue of the powers vested in me by law, do hereby order the organization of the Local School Board with its corresponding duties and functions.

SECTION 2. DUTIES AND FUNCTIONS OF THE BOARD

1. Determine in accordance with the criteria set by the Department of Education, the annual supplementary budgetary needs for the operation and maintenance of public schools within the municipality, as the case may be, and the supplementary local cost of meeting such needs which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as the Code and other laws or ordinance may provide;
2. Authorize the Municipal Treasurer, as the case may be, to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with applicable existing rules and regulations;
3. Serve as an advisory committee to the Sanggunian on educational matters such as, but not limited to, the necessity for and uses of local appropriations for educational purposes; and
4. Recommend changes in the names of public schools within the territorial jurisdiction of the municipal government unit for enactment by the Sanggunian.

Section 3. MEETINGS. The Local School Board shall meet once every month or as often as maybe necessary.

Section 4. EFFECTIVITY. This executive order shall take effect immediately and shall remain in force unless revoked for any cause.
