Section 2 – FUNCTIONS. The council shall perform these functions:

1. Formulate long-term, medium-term and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law and competent authority.

Section 3. MEETINGS: The MDC shall meet at least once every six (6) months or as often as necessary.

Duties and Functions: shall be responsible for providing technical and administrative support, documenting proceedings, preparing reports; and providing such other assistance as may be required by the MDC.

POWERS and FUNCTIONS

1. Ensure that decisions of the Council are faithfully carried out and implemented.
2. Act on matters requiring immediate attention or action by the Council
3. Formulate policies, plans and programs based on the general principles laid down by the Council; and
4. Act on the other matters that may be authorized by the Council

Section 6. Functions of the Sectoral and Functional Committees.

The committee shall exercise the following powers and functions:

1. Provide the LDC with data and information essential to the formulation of plans, programs and activities;
2. Define the sectoral or functional objectives, set targets, and identify PPA's for the particular Sector;
3. Collate and analyze information and statistics;
4. Conduct public hearing on vital issues affecting the sector and functions;
5. Coordinate planning, programming, and implementation of PPA's within each sector
6. Monitor and evaluate programs and budgets;
7. Perform such other functions as may be assigned by LDC.

This **ORDER** shall take effect immediately.
