EXECUTIVE ORDER NO. 04 Series of 2022

AN ORDER ESTABLISHING THE CIVIL SOCIETY ORGANIZATION (CSO) DESK AND DESIGNATING THE CSO DESK OFFICER OF THE MUNICIPALITY OF CAMALANIUGAN

WHEREAS, Article 62, Rule XIII of the Local government Code provided that the Local Government Units (LGUs) shall promote the establishment and operation of non-government organizations, people's organizations and private sector to make them active partners in the pursuit of local autonomy, and to directly involve them in planning and implementation of programs and projects of the LGUs. Article 64 of the same IRR, provides for the procedure and guidelines in the accreditation of representatives to the LSBs;

WHEREAS, the participation of CSOs in government processes is important for the purpose of providing check and balance as well as in exacting accountability;

WHEREAS, the Department of the Interior and Local Government has issued Memorandum Circular No. 2021-054, an amendatory issuance to DILG MC 2021-012 to address the issues raised on the operationalization of key concepts introduced in the policy;

WHEREAS, the amendatory issuance enjoins local government units to establish their respective CSO Desks and to create and institutionalize the Local People's Council in every province, city and municipality;

NOW THEREFORE, by the powers vested in me by law, I, **ISIDRO T. CABADDU**, Municipal Mayor of Camalaniugan, Cagayan do hereby order the following;

SECTION 1. Establishment of a CSO Desk and Designation of CSO Desk Officer.

Designated as CSO Desk Officer of Camalaniugan is **MAY ROSE L. BARREIRO** Project Development Assistant of the Municipal Planning & Development Office.

SECTION 2. FUNCTIONS. The CSO Desk Officer shall perform the following functions:

1. Serve as a venue to document and address the issues and concerns of CSOs in the locality;
2. Assist CSOs intending to apply for accreditation to a local special body and/or participate in local government programs, including the People's Council; and
3. Encourage the active participation of CSOs in all local governance processes from planning, implementing, monitoring and evaluating programs, projects and activities through the spirit of volunteerism;
4. Monitor the People's Council and CSOs participation in the programs, projects and activities of the local government;
5. Maintain and update local CSO database

SECTION 3. EFFECTIVITY. This Order takes effect immediately.
