



EXECUTIVE ORDER NO. 46 Series of 2022

AN ORDER ORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF CAMALANIUGAN

WHEREAS, the recently-concluded National and Local Elections has brought about changes in the mandatory composition of the council;

SECTION 2. FUNCTIONS: The MDRRMC shall have the following functions:

- 1) Approve, monitor and evaluate the Implementation of the MDRRMP and regularly review and test the plan consistent with other national and local planning programs;
- 2) Ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs and budgets as a strategy in sustainable development and poverty;
- 3) Recommend the implementation of the forced or preemptive evacuation of local residents, if necessary; and
- 4) Convince the municipal council once every three (3) months or necessary.

SECTION 3. COMPOSITION AND FUNCTIONS OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO)

The MDRRMO in the municipality of Camalaniugan shall be responsible for the direction, development, implementation and coordination of disaster risk management programs and shall be composed as follows:
