



**EXECUTIVE ORDER NO. 01  
Series of 2023**

**AN ORDER ORGANIZING THE LOCAL PRICE COORDINATING COUNCIL (LPCC)  
IN THE MUNICIPALITY OF CAMALANIUGAN**

**WHEREAS**, it is the policy of the state to ensure the availability of basic necessities and price commodities at reasonable prices at all times without denying legitimate business a fair return on investment.

**WHEREAS**, as provided for under **Section 11 of Republic Act 7581**, otherwise known as the "**Price Act and Rule VI Section 1 of DTI, DA, DOH and DENR Joint Administrative Order No. 1 Series of 1993**", there shall be a created Local Price Coordinating Council (LPCC) to monitor the prices and supply of basic necessities and prime commodities and to prescribe measures to stabilize such prices and supply of such goods, especially during period of calamity, emergency, widespread illegal price manipulation and other similar occasions for the protection of consumers;

**WHEREAS**, the recently concluded National and Local Elections has brought about changes in the mandatory composition of the council.

**NOW, THEREFORE, I, ISIDRO T. CABADDU**, Municipal Mayor of the Municipality of Camalaniugan, Province of Cagayan, by virtue of the powers and authority vested in me by law, do hereby order the Organization of the Local Price Coordinating Council as follows:

**SECTION 1: COMPOSITION.** The Local Price Coordinating Council shall be composed of the following:

**SECTION 2: POWERS AND FUNCTIONS.** Concerned member-agencies and sectoral representatives shall assist the Local Chief Executive of Camalaniugan in the following:

1. To conduct a regular price and supply monitoring activities of basic necessities and prime commodities;
2. To make an in-depth analysis on causes of any price manipulation whenever it occurs; and
3. To recommend to the body, action steps to correct any unwarranted price increase and supply shortage in accordance with the applicable provisions of Republic Act 7581, the "Price Act" as amended under Republic Act 10263 and Republic Act 10121, the Philippine Disaster Risk Reduction and Management Act and their Implementing Rules and Regulations, respectively.

**SECTION 3: COUNCIL MEETINGS.** The council regular meeting shall be every after two (2) months while special meeting shall be called upon as the need arises. All council meetings shall be presided by the Chairman. However, in the absence of the Chairman and Vice-Chair and if the need arises, the members present shall select among themselves a temporary presiding officer to preside such meeting.

**SECTION 7: EFFECTIVITY.** This order shall take effect immediately upon its approval.
