

EXECUTIVE ORDER NO. 05 Series of 2023

AN ORDER ORGANIZING THE COMPOSITION OF THE MUNICIPAL MARKET COMMITTEE

WHEREAS, Chapter 4, Article A, Section 39, of the Market Code of the Municipality provides that there shall be created a Market Committee, whose duty shall be to adjudicate or conduct the drawing of lots in connection with the awarding of vacant or newly constructed stalls or booths in the public market, and to certify to the Municipal Mayor the results thereof and perform such other duties and functions as prescribed under this code;

WHEREAS, the Municipal Market Committee requires another reorganization to accommodate new members;

NOW THEREFORE, I, ISIDRO T. CABADDU, Municipal Mayor of Camalaniugan, Cagayan by virtue of the power vested in me by law, do hereby order:

Section 1. Reorganization of the Municipal Market Committee new composition as follows:

Section 2. Term of Office. Unless otherwise removed for a cause, the members of the Market Committee shall remain as members.

Section 3. Duties and Functions. The committee shall perform these functions as follows:

- To advertise and/or cause the posting of notice of stall vacancies in conspicuous places within the premises of the Camalaniugan Public Market and in the Municipal Hall:
- To formulate policy guidelines for the pre-qualification of stall applicants and in the awarding of stalls;
- To conduct pre-qualification of stall applicants for the purpose of determining the eligibility based on the set of qualification standards and recommend stall awardees for approval of the Municipal Mayor;
- 4. To ensure that stall lessees shall abide by the terms and conditions of the Stall Contract Agreement and shall prepare and submit to the Office of the Mayor a quarterly stall monitoring report which contain among others the name of the Store Lessee, the number and location of stall occupied. The monthly rental rate per stall and other important information that could serve as basis for policy and decision making.
- To recommend for appropriate action of the Municipal Mayor any and all stall lessees
 who are found to have violated provision of the Stall Lease Contract Agreement that
 may be sufficient ground for ejection or termination of their stall lease contract
 agreement
- 6. In case where the deliberations of the Market Committee results in a tie vote, the Chairman shall break the tie;
- 7. To hear and settle grievance arising out of market operation;
- 8. To assist market personnel in the implementation of general sanitation and orderliness at the public market

Section 4. Quorum and Meetings. The Municipal Market Committee shall meet regular monthly or whenever necessary;

Section 5. Secretariat. To expedite the processing of the awarding of the stalls for practical intents and purpose, a secretariat is created to be composed of the following:

Section 6. Compensation. No additional compensation of whatsoever kind and nature is granted to any member of the Market Committee.

Section 7. Effectivity. This Executive Order shall take effect immediately.
