



**EXECUTIVE ORDER NO. 09**

**AN ORDER CONSTITUTING THE MUNICIPAL EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COORDINATING COMMITTEE**

**WHEREAS**, it is the policy of the State to promote the rights of children to survival, development and special participation with full recognition of the nature of childhood and its special needs; and to support the parents in their roles as primary caregivers as their child's first teachers;

**WHEREAS**, in consonance with the said policy, Republic Act No. 10410 otherwise known as the Early Years Act (EYA) has been approved to institutionalize a national system for Early Childhood Care and Development (ECCD) that is comprehensive, integrative, sustainable and involves multi-sectoral and inter-agency collaboration at the national and local government levels among the government; among service providers, families and communities and among public and private sectors, non-government organizations (NGOs), professional associations and academic institutions;

**WHEREAS**, DILG Memorandum Circular No. 20222-121 prescribed the Guidelines on the Organization and Strengthening of the Local Councils for the Protection of Children (LCPC) incorporating thereat the creation of Early Childhood Care and Development (ECCD) Coordinating Committee at the Provincial, City Municipal and Barangay levels;

**WHEREAS**, the Municipality of Camalaniugan is supportive to the mandate of the law and circular considering that the same boils down to the best interest and welfare of children;

**NOW, THEREFORE, I, ISIDRO T. CABADDU**, Municipal Mayor of the Municipality of Camalaniugan, by virtue of powers vested in me by law, do hereby order the Constitution of the Municipal Early Childhood Care and Development (ECCD) Coordinating Committee with the composition and functions as follows:

**SECTION 1. Composition of the Municipal Early Childhood Care and Development (ECCD) Coordinating Committee.**

## **SECTION 2. FUNCTIONS OF THE MECCDC:**


1. Formulate the long term and short term and annual plans and policies of the city about the Early Childhood Care and Development Program and recommend the same to the Local Chief Executive for approval;
2. Coordinate and monitor the implementation of the municipal ECCD programs;
3. Coordinate and support all barangays in the municipality in their ECCD programs;
4. Mobilize and encourage private sectors initiatives about ECCD programs;
5. Come up with a documentation of all ECCD programs of the municipality including those already implemented; and
6. Perform such other functions as maybe directed by the Mayor in accordance with existing laws and ordinances.


## **SECTION 3. SECRETARIAT**

The Municipal Social Services and Welfare Development Office shall act as Secretariat which shall coordinate and monitor the effective implementation of the ECCD programs in the municipality.:

**SECTION 4. EFFECTIVITY** - This Order takes effect immediately.
