



EXECUTIVE ORDER NO. 24 Series of 2023

AN ORDER ORGANIZING THE MUNICIPAL PEACE AND ORDER COUNCIL OF CAMALANIUGAN, CAGAYAN

WHEREAS, Section 116 of Republic Act No. 7160, or the "Local Government Code of 1991", and Executive Order No. 773, s. 2009 calls for the reorganization of the Peace and Order Council in every Province, City, and Municipality;

WHEREAS, Executive Order No. 773 dated January 5, 2009 which provides for the composition of the reorganization of the Peace and Order Council at all levels;

WHEREAS, the recently-concluded National and Local Elections has brought about changes in the mandatory composition of the council;

WHEREAS, the council shall focus on the convergence and orchestration of civil authorities and agencies, military and police efforts to address peace and order, particularly the fight against illegal drugs;

WHEREAS, the council shall continue to sustain their cause to promote peace and order and public safety for the Municipality of Camalaniugan;

NOW, THEREFORE, I, ISIDRO T. CABADDU, by virtue of the powers vested in me by law, do hereby organize the Municipal Peace and Order Council, as provided hereunder:

SECTION I. COMPOSITION

The Cagayan Peace and Order Council shall be constituted with the following composition:

SECTION II. DUTIES AND FUNCTIONS

1. Provide a forum for dialogue and deliberation of major issues and major problems affecting peace and order, including insurgency;
2. Recommend measures which will improve or enhance peace and order and public safety in their respective areas of responsibility, including anti - insurgency measures;
3. Recommend measures to converge and orchestrate internal security operations efforts of civil authorities and agencies, military and police;
4. Formulate a 3-year LPOC Peace and Order and Public Safety (POPS) Plan;
5. Create a Technical Working Group (TWG) for the purpose of POPS Planning, following the guidelines prescribed by the DILG on the tools and process on POPS Planning;
6. Create a Special Action Committee (SAC) to address the immediate issues on peace and order and public safety, in case of emergencies;
7. Apply moral suasion to and/or recommend sanctions against local chief executives who are giving material and political support to the Communist rebels;
8. Monitor the provision of livelihood and infrastructure development programs and projects in the remote rural and indigenous population areas adopted to isolate them from the Communist rebels' "Agitate/Arouse, Organize and Mobilize" and ideological, political and organization works;
9. Serve as the convergence mechanism to support the Comprehensive Local Integration Program (CLIP) Committee in its implementation, at the Municipal level;
10. Submit semestral POC Accomplishment Report to the NPOC, through the POC Secretariat;
11. Provide staff/s and financial support to POC Secretariat; and
12. Perform all other functions assigned by law, the President or the NPOC.

The Civilian Volunteer Organizations (CVOs) shall be managed and supervised by the Chief of Police.

SECTION III. SECRETARIAT

The Municipal Peace and Order Council Secretariat shall be composed of the following:

The secretariat shall handle the administrative and technical activities of the Council and it shall also undertake liasoning and coordination of activities with appropriate agencies of the government.

Moreover, the secretariat shall be assisted in its functions and duties by the regular staff of the Council Chairman.

The following are the tasks and responsibilities of the POPS Planning TWG:

1. Prepare documents that could serve as reference for the profiling of the strategic direction and peace and order and public safety issues in the locality;
2. Conduct data gathering and stakeholder consultations as needed and analyze data gathered;
3. Coordinate with concerned stakeholders for data gathering and action planning for implementation of POPS Plan;



4. Present data to the PPOC for prioritization of issues and development of strategies;
5. Participate in the POPS planning process, drafts parts of the POPS Plan as assigned, and participate in the write shop that would finalize the POPS Plan;
6. In coordination with the Governor, convene the PPOC and present the plan for discussion, approval, and appropriate action;
7. Take part in the submission and adoption of the POPS Plan;
8. Coordinate with internal and external stakeholders for effective communication and monitoring as laid out in the POPS Plan;
9. Ensure inclusion of key programs or strategies such as Enhanced Comprehensive Local Integration Program (ECLIP), among others, if deemed appropriate, in the POPS Plan;
10. Establish and manage a monitoring and evaluation system and regularly submit Accomplishment Reports (ARs). Coordinate adjustments to the POPS Plan as needed.
