## EXECUTIVE ORDER NO. 29 Series of 2023

### AN ORDER ORGANIZING THE MUNICIPALITY PERFORMANCE ASSESSMENT TEAM FOR THE CY 2023 IMPLEMENTATION OF THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB)

**WHEREAS**, Section 5, Article II of the 1987 Constitution of the Republic of the Philippines declares that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

**WHEREAS**, Section 32 of the LGC of 1991 provides for the city and municipal supervision over their respective barangays. Through the city or municipal mayor concerned, they shall exercise general supervision over component barangays to ensure that said barangays act within the scope of their prescribed powers and functions;

**WHEREAS**, Section 17 (b) (2) of Republic Act No. 7160, declares the provision of the minimum basic services and facilities in the barangay;

**WHEREAS**, Section 1, Executive Order No. 138 entitled: Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for Other Purposes states that National Government (NG) is fully committed to the policy of decentralization enshrined in the Constitution and relevant laws which are aimed at 1) developing capabilities of local governments to deliver basic social services and critical facilities to their constituents, increase productivity and employment, and promote local and economic growth; and, 2) ensuring accountability, competence, professionalism and transparency of local leaders through the development of institutional systems that uphold good governance and strengthen their capacities for managing public resources;

**WHEREAS**, per DILG MC No. \_\_, for CY 2023, the DILG – National Barangay Operations Office (NBOO) shall roll-out the SGLGB for purposes of assessing the performance of the barangays, covering 2022 as the year under review;

**WHEREAS**, per DILG MC No. \_\_, all local chief executives of provinces, cities and municipalities shall issue an Executive Order organizing the 2023 SGLGB Performance Assessment Team in their respective jurisdictions.

**NOW, THEREFORE**, I, **Isidro T. Cabaddu**, Municipal Mayor of Camalaniugan by virtue of the powers vested in me by law, do hereby order the organization of the Municipality SGLGB Performance Assessment Teams (PAT) for the CY 2023 implementation of the SGLGB.

## Section 2. ROLES AND RESPONSIBILITIES

The M PAT shall perform the following functions:

- Assess the performance of the barangays based on the indicators in the Data Capture Form (DCF, SGLGB Form 2) vis-à-vis the submitted Means of Verification (MOVs) of the barangays;
- Sign and certify as to the correctness of the DCF;
- Approve and sign the Component City/Municipal Consolidated Performance Assessment Form (M CPAF, SGLGB Form 4); and
- Ensure the completion of the assessment, certification and encoding within the scheduled timeframe.

The M Planning and Development Office as Secretariat of the M PAT shall perform the following functions:

- Ensure the completeness of all MOVs of barangay entries based on the submitted Documentary Checklist;
- Present to the CC/M PAT, during the assessment meeting, all submitted Form 1 and MOVs of barangays;
- Accomplish the DCF (SGLGB Form 2) based on the assessment of the M PAT;
- Facilitate the accomplishment and signing of CC/M CPAF by the M PAT;
- Submit the signed M CPAF to the Provincial Performance Assessment Team (PPAT), except for the Municipality of Pateros in the National Capital Region (NCR), which shall submit directly to the Regional Performance Assessment Team (RPAT); and
- Encode the assessment data of all barangays in the SGLGB Google Sheet based on the DCF signed by the M PAT.

The MLGOO as Coordinator shall perform the following functions:

- Perform quality check of all barangay entries, by ensuring that all MOVs and forms submitted are true and correct;
- Ensure that the M PAT and its Secretariat have complied with all the process requirements in the assessment of their barangays; and
- Assist the M PAT in coordinating SGLGB concerns.

**Section 3. EFFECTIVITY.** This Order shall take effect immediately.
