



## EXECUTIVE ORDER NO. 31 Series 2023

### AN ORDER ORGANIZING THE HOUSING & RESETTLEMENT PROJECT MONITORING AND EVALUATION COMMITTEE IN THE MUNICIPALITY OF CAMALANIUGAN

**WHEREAS**, it is the declared policy of the state to provide the people with adequate and decent housing facilities and to encourage various stakeholders, both in and out of the government to actively participate in the housing program of the government;

**WHEREAS**, the Local Government of Camalaniugan, Cagayan with its approved Housing Project with the National Housing Authority (NHA) has entered into Memorandum of Agreement (MOA) with NHA which states among others in Article III, Section 3.7.1 that Local Inter-Agency Committee (LIAC) be created purposely to ensure adequate consultation and participation in the project implementation and monitoring and generally in the management operation of the Housing Resettlement Project;

**NOW THEREFORE**, I, **ISIDRO T. CABADDU**, Municipal Mayor of the Municipality of Camalaniugan, Province of Cagayan, by virtue of the powers vested in me by law, do hereby order the Organization of the Housing and Resettlement Project Monitoring & Evaluation Committee in the municipality;

**Section 2. Functions:** The Committee shall perform the following functions:

- a. Collect and process reports of implementers and NGO monitors on the status of housing and settlement project implementation;
- b. Pinpoint problems, verify information and recommend remedial measures to be submitted for analysis and action of concerned authorities;
- c. Provide feedback on the remedial actions;
- d. Prepare and disseminate regular project monitoring reports on the status of project implementation; and
- e. Elevate to higher-level authorities problems/ issues, which are not resolved at their level.


**Section 3. Meeting.** The Housing and Resettlement Project Monitoring & Evaluation Committee shall hold a regular quarterly meeting or as often as necessary to discuss problems and issues affecting the implementation of housing/settlement project/s and remedial actions to be elevated to the management/concerned authorities.

**Section 4. Secretariat.** The Municipal Planning and Development Office thru Enp JACQUELINE U. BUCAYU shall serve as Secretariat to the committee with functions as follows:

1. Prepare the monitoring program to be undertaken by the Committee
2. Facilitate and coordinate conduct of meetings and monitoring per se
3. Keep records relative to monitoring and evaluation of the committee

**Section 5. Effectivity.** This Order shall take effect upon approval.
