

EXECUTIVE ORDER NO. 03 Series of 2024

AN ORDER UPDATING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF CAMALANIUGAN

WHEREAS, updating of the MDRRMC is imperative to include new members that would ensure the continuity of functions and programs of the council and maintain its effectiveness towards DRRM initiatives and actions;

SECTION 2. FUNCTIONS: The MDRRMC shall have the following functions:

- Approve, monitor and evaluate the Implementation of the MDRRMP and regularly review and test the plan consistent with other national and local planning programs;
- Ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs and budgets as a strategy in sustainable development and poverty;
- 3) Recommend the implementation of the forced or preemptive evacuation of local residents, if necessary; and
- 4) Convince the municipal council once every three (3) months or necessary.

SECTION 3. COMPOSITION AND FUNCTIONS OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO)

The MDRRMO in the municipality of Camalaniugan shall be responsible for the direction, development, implementation and coordination of disaster risk management programs and shall be composed as follows:
