**AN ORDER RECONSTITUTING THE COMMITTEE ON ANTI-RED TAPE (CART) OF
THE MUNICIPALITY OF CAMALANIUGAN**

WHEREAS, RA No. 11032, otherwise known as the “Ease of Doing Business and Efficient Government Service Delivery Act of 2018 mandates all government offices to adopt simplified requirements and procedures that will reduce red tape and expedite business and non-business-related transactions;

WHEREAS, Memorandum Circular (MC) No. 2020- 07 issued by the Anti-Red Tape Authority directs all government to create a Committee on Anti-Red Tape (CART) to comply with RA No. 11032 and its IRR;

WHEREAS, CART was created by virtue of Executive Order No. 66, Series of 2022 and is due for updating to ensure efficient functioning;

NOW THEREFORE, I, **ISIDRO T. CABADDU**, Municipal Mayor of Camalaniugan, by virtue of the power vested in me by law, do hereby order the Reconstitution of the Committee on Anti-Red Tape (CART) of the Municipality of Camalaniugan with the following stipulations :

SECTION 2. FUNCTIONS: The CART shall ensure compliance with the requirements of R.A. No. 11032, its Implementing Rules and Regulations and subsequent issuances by the ARTA, as applicable.

SECTION 3. SECRETARIAT. The Human Resource Management Office shall serve as the Committee's Secretariat tasked to handle all administrative and secretariat activities.

SECTION 4 . OPERATIONAL FUNDS. All costs pertaining to the operations of the Committee shall be chargeable against available funds and resources of the local government, subject to the usual accounting and auditing rules.

SECTION 5 . REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Order are hereby repealed or mmodified accordingly.

SECTION 6. EFFECTIVITY: This order shall take effect immediately.
