

EXECUTIVE ORDER NO. 45 Series 2023

AN ORDER REORGANIZING THE MUNICIPAL TOURISM CULTURE AND THE ARTS COUNCIL

WHEREAS, pursuant to DILG Circular No. 95-162 and in furtherance of Section 17 of the Local Government Code of 1991 the Municipal Tourism Council was organized and last updated on December 27, 2019 by virtue of Executive Order No. 102, Series of 2019;

NOW THEREFORE,

I, **ISIDRO T. CABADDU**, Municipal Mayor of the Municipality of Camalaniugan, Province of Cagayan, by virtue of the power vested on me by law and on the sovereign will of the people, do hereby order the reorganization of the Municipal Tourism Culture & the Arts Council;

- a. To formulate programs and recommendations to develop tourism facilities and attractions in the place;
- b. To assist in the regulation and supervision of tourism-oriented establishments/enterprises to ensure wholesome tourism activities;
- c. To act as consultative body and representative on matters affecting the tourism industry/activity;
- d. To coordinate efforts of both public and private sectors that boost local tourism;
- e. To spearhead efforts in the formulation of policy and encouraging the Sangguniang Bayan to propose legislation supporting the tourism industry in accordance with the Tourism Act of 2009;

SECTION 3. SECRETARIAT. There is hereby a designated Secretariat for the council with the following membership and respective functions:

- 1. Provide technical and administrative support
- 2. Document all proceedings of the council
- 3. Prepare the minutes of the meetings, resolutions, recommendations and reports
- 4. Serve and follow-up communications to concerned individuals and sectors
- 5. Keep the records of the council
- 6. Provide such other assistance as maybe required by the council

SECTION 4. MEETINGS. The Council shall meet as deemed necessary.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately upon approval.
